



WAITING LIST OPENING
PROJECT-BASED VOUCHER (SECTION 8) PROGRAM
ALFRED E. PLANT SENIOR (55+) APARTMENTS

The Housing Authority of the Town of West Hartford (WHHA) will be accepting pre-applications for apartments in the Project Based Voucher (PBV) Program component of Alfred E. Plant Senior Apartments, which is located at 759 Farmington Avenue, West Hartford CT 06119.

The PBV Program is a federally-funded program which provides units with rental subsidies to eligible households. Applicants must meet all U.S. Department of Housing and Urban Development and WHHA income and eligibility guidelines.

As additional eligibility requirements, the applicant or other adult household member must be at least 55 years of age or older, household members under the age of 18 may not be part of an application, must be eligible by household size for efficiency (0 BR) or one (1 BR) unit and meet the income and other eligibility guidelines set by the U.S. Department of Housing and Urban Development (HUD).

Only one pre-application per family will be accepted; duplicate pre-applications will be disqualified.

This pre-application is accessible through any computer, tablet or smart phone. After successfully completing the pre-application, you may print the confirmation of successful completion of your application.

The Housing Authority of the Town of West Hartford will use a Random-Draw Lottery System to select 400 pre-applications from among eligible pre-applications. The date and time of your application will not impact the selection or placement on the waiting list. Those chosen in the lottery will be notified by mail no later than August 1, 2022. All disqualified or remaining pre-applications not selected for the lottery will be discarded with no further notice. Therefore, if you do not receive a letter by August 1, 2022, your pre-application was not drawn.

The Housing Authority of the Town of West Hartford does not discriminate in admission or access to federally assisted housing programs. Any eligible individual with disabilities will be served. Those who have visual or hearing impairments will be provided with the necessary information to understand and participate in the program. Efforts will be coordinated to comply with the nondiscrimination requirements of Section 504. This is an equal opportunity housing program.
